Questions of how to structure and select, how lives can be written in an authentic way, and how to do justice to other's lives will be tackled. Students will also experience, through appreciating masterpieces of biographical writing, the diverse ways in which other authors have also written lives.

Reflective essay	15 %	1, 2, 3, 4, 5	A reflective and analytical essay of 1500 - 2000 words on the research, planning and writing undertaken for items 1 and 2, including reflection on the theoretical issues involved in biographical writing.
Examination	30 %	1, 2, 3, 4	A written examination to test students' knowledge on the biographical genre, and their ability to apply writing strategies and skills learned in the course.
